

39th Euromineralexpo • October (7th) - 8th - 9th - 10th, 2010 Regulations

1. The exhibitors of « Euromineralexpo » fair are international professional workers and lovers in the mineral field. The exhibition promoters can invite no more than 20% of exhibitors that work in a different sector.
2. All exhibitors have to respect the opening and closing time and they should keep their expository area clean and leave it in order.
3. The exhibitor states that he is the only responsible for what is exhibited, in topical laws or rules that regulates his sector. The exhibitor is the only to be conscious and responsible in front of the juridical and fiscal area that regulates his exhibition, exchange or negotiation of goods.
4. The exhibitor should be well polite towards the exhibition promoters, the other exhibitors and the visitors.
5. The organizers choose whether accept admission of exhibitors, considering: registration date, representativeness, honesty and so on. The organization does not exert racial or political discrimination.
6. The organizers claim the right not to accept the participation at the fair or to send out immediately from the exhibition hall, exhibitors, visitors or any person who damages or troubles the fair.
7. The exhibitor exerts his do only in his exhibition site. In this site the exhibitor cannot invite anyone who was refused like “exhibitor” and wants to exert however his job. The exhibitor cannot give up his site, but if it is necessary, he can give it back to the promoter.
8. Permission of organization is required for anything publicity (leaflets or other different objects). Sound publicity and peddlers are not admitted.
9. The badge to operate on “Euromineralexpo” is like an identity card and it is not transferable. The exhibitor is responsible on behalf of his collaborators, he must be disposal at the organization control and he is obliged to show his papers to compare his name with the one written on the badge.
10. The non-observance of point “9” obliges the organizers to expel the person responsible and in serious case to send for security police or in addition to make a report.
11. The organization is exempt of liability for any loss or damage caused, even if ensures security during the night. If in case of “force majeure” “Euromineralexpo exhibition could not take place, as the one responsibility, the organization will settle the amount just paid.
12. Acceptance of the technical regulations of Lingotto Fiere
13. Further unforeseeable rules will be soon communicated during the exhibition.
14. Application for participation will made by completing the enclosed form together with exhibitor’s legally binding signature and it has validity only with the payment of the account. Organizers will confirm the booking in writing, without this confirmation the applicant cannot become exhibitor, obtain the badge and to stay in the exhibition hall.
15. In default of payment the organization exerts a right to the goods and equipment that are in the exhibition place, therefore the goods and the equipment of defaulting debtors are not allowed to go out.
16. The display area is the only one chosen by the exhibitors, it is visible on the map of the pavilion and on the written confirmation that ratifies the participation of the exhibitor and delimits his area of competence that cannot be absolutely extended.
17. The exhibition planes should be covered with a cloth provided by the exhibitor in order to be protected from any damage. The cloth has to go down for at least 70 centimetres on the side of the visitors. The space under the planes may be used as a warehouse of goods that will be shown exclusively on the tops.
18. It is absolutely forbidden to invade the area reserved for the public.
19. The exhibitor can exercise his activity, sit, move his goods within 90 centimetres behind the exhibition planes. The exhibitor can place a little plane to lay support tools such as : mobile phones, cash registers, calculators etc. only if this little plane is lower than the exhibition one. Behind this area there is a corridor of 60 centimetres that have to be free and available for the passage of the security and the organizers for the necessary controls.
20. The exhibitor cannot enter into the exhibition hall if he is not up to date with his payments.
